Prior to Joining AAUW Kim was the managing director of the Brookings Institution, an internationally recognized public policy think tank, where she strategically guided Brookings, providing vision and problem-solving skills while focusing on expansive partnerships, external relations, and advancement.

In addition to her work at AAUW, Kimberly currently serves as the chair of the Build Metro D.C. board, which demonstrates the power of experiential learning through entrepreneurship for under-resourced-communities, and is a member of the Association of Fundraising Professionals PAC Board. She is also a member of the International Women's Forum of Washington, D.C., an organization that represents women leaders in diverse fields and whose mission is to further dynamic leadership and leverage global access to and maximize opportunities for women in 33 countries on 6 continents.

Julia earned her law degree from the University of Oklahoma, has served in the U.S Army, worked in corporate America and at all levels of government in Oklahoma, the District of Columbia, California, and New Mexico. Julia brings her varied experience to AAUW, where she belongs to two branches (Las Cruces, N.M and Oakland-Piedmont, CA), is a life member and a Legacy Circle member. She has served AAUW, the business community and in the public sector at all levels on boards and commissions, and in senior management. She has received many awards for her varied service, and in late 2016 she was presented with the President's Lifetime Achievement Award for Volunteer and Community Service.



Susan Landino, filed the first non-sports-related Jackson v Birmingham **Title IX** retaliation complaint. **Burhans v Yale** was supported by the American Association of University Women made possible by our



LAF donations. Susan worked in news broadcasting and the entertainment industry in Los Angeles, then pursued a graduate degree and worked in the vice president's office at Yale University in 1999. There Landino witnessed illegal activities that impacted student's civil rights in the aftermath of sexual assault and harassment and caught the university falsifying crime statistics. She was the target of personal harassment, retaliation, was fired and treated like a criminal. Her story of her fight for justice for herself and the other victims promises to be infuriating but redeeming.

Susan has founded **Allies Reaching for Equality** to support intersectional populations navigating inequities linked to Title IX non-compliance affecting access to education. She just received her first funding and has published an op-ed in the

Philadelphia Inquirer launching the foundation.
