AAUW Colorado 2022 Priority Bills

Active Support—10 Bills

9 passed and were signed by the Governor

1 was incorporated into the School Finance Act

Support—68 Bills

60 passed and were signed by the Governor

5 were PI'd (killed)

3 died on the calendar

1 substitute bill passed and will be on the Nov 2022 ballot



AAUW Colorado 2021 Priority Bills

(cont)

Active Opposition—15 Bills

14 PI'd (Killed)

1 Passed and was signed by the Governor (SB22-197-
Alternative Governance for Innovation School Zones)

Opposition—2 Bills

Both bills PI'd (Killed)



AAUW Colorado 2022 Priority Bills

Active Support—All passed and were signed by the Governor

- HB22-1002 5th Year High School Concurrent Enrollment
(was incorporated into the School Finance Bill)
- HB22-1008 Implementation of Fertility Coverage
- HB22-1010 Income Tax Credit for Early Childhood Educators
- HB22-1055 No sales tax on feminine hygiene products and diapers
(child & adult)

AAUW Colorado 2022 Priority Bills

Active Support (cont.)-- All passed and were signed by the Governor

- HB22-1057 Temporary waiver allowing retired teachers to work in any district without losing PERA Benefits
- HB22-1101 Permanent waiver on hours worked for retired teachers in rural schools
- HB22-1133 Family And Medical Leave Insurance Fund

Active Support (cont.)-- All passed and were signed by the Governor

- HB22-1279 Reproductive Health Equity Act (RHEA)

- SB22-207 Study Title IX Misconduct in Public Schools
- SB22-213 Child Care Support Programs

AAUW Colorado 2022 Priority Bills

Active Opposition—All of these bills failed

- HB22-1021 Reduce State Income Tax Rate
- HB22-1033 Eliminate Concealed Carry Permit
- HB22-1047 Protecting Human Life At Conception
- HB22-1075 State Registrar Induced Termination Of Pregnancy

Active Opposition (cont.)—All Failed, except SB22-039

- HB22-1079 Abolishing Abortion In Colorado
- HB22-1106 Concealed Handguns On School Grounds
- HB22-1125 Income Tax Rate Reduction
- SB22-039 Funding For Educational Opportunities (Vouchers)
